# The Corona Crisis - A Critical Analysis for Germany

Three years of the Corona pandemic. The spook now seems to be finally over in Germany, too. Time for an analysis.

#### **Pandemic - Laboratory pandemic**

With the emergence of swine flu, the WHO changed the definition of a pandemic in 2009. Whereas a pandemic previously required that "a substantial number" of deaths be caused by the disease, the new definition omits this addition. Thus, a pandemic is defined as "an epidemic... that usually affects large numbers of people." WHO is working with the European Scientific Working Group on Influenza (ESWI). The ESWI is a lobbying group for the pharmaceutical industry.

The Corona pandemic was only made possible by a questionable PCR test. Suddenly, healthy people were declared sick by a false positive PCR test, with drastic consequences for their social life. No PCR test can detect any infection.

#### **Death Figures**

Death from coronavirus (SARS-CoV2) occurs when 28 days before death the patient has a positive PCR test (WHO). Whether the death was due to cancer, accident or suicide is irrelevant. A serious measurement of the number of deaths in Germany in connection with SARS-CoV2 never took place. The official statement *"died of or with Corona"* is still valid today. Most true corona deaths had multiple prior illnesses. Age is also important. According to the RKI, the median age in Germany is 84 years. The main risk group is formed by the elderly, with those over 80 years of age being particularly affected. It is obvious that old people generally suffer more from viral infections. Aging is accompanied by a reduction in the immune defense system.

### The Fairy Tale With The Masks

The pore size of an FFP mask is 0.600  $\mu$ m. Corona viruses are 0.125-0.160  $\mu$ m in size. Corona virus rushes through the mask, as do all other viruses. Viruses travel in water droplets, in aerosols. The average size of aerosols is 0.1-0.3  $\mu$ m. They also rush through. In China, as well as in other Asian countries, wearing masks is an everyday ritual. Despite mask-wearing, large outbreaks have occurred there. No mask can stop a virus. Masks give a false sense of security and are a potential source of danger for the wearer (source of infection, microplastics, breath retention).

#### **Questionable Vaccines**

The WHO claims that 1 million lives have been saved by Corona vaccinations in Europe alone. This is based on mathematical modeling, the validity of which must be evaluated with reservations. Equally questionable is the claim that the vaccinations have prevented a "*severe course*". This assertion cannot be illustrated with figures.

• However, the low efficacy of the mRNA vaccines, which is significantly below 50%, can be illustrated with figures.

• Neither does the vaccine guarantee sufficient self-protection nor protection for others. Repeatedly vaccinated individuals repeatedly re-infect themselves with Corona and infect others. The RNA vaccine does not produce a stable and sterile immune response.

• The negative effect of mRNA vaccines on the immune system is measurable: mRNA vaccines have been shown to reduce innate immunity, especially interferons, responsible for antiviral defense.

• EMA (European Medicines Agency): September 2022 - 404,000 cases registered with serious adverse events after Corona vaccinations. April 2023: 1,589,595 reported cases of adverse reactions (BioNTech/ Pfizer and Moderna).

#### Parkinson's disease and mRNA vaccination

Experimental laboratory studies show that the corona spike protein, the vaccine antigen, interacts with the  $\alpha$ -synuclein protein. This interaction enhances the expression of  $\alpha$ -synuclein. Overproduction of this protein leads to a disease flare in vivo. Normally, an mRNA is degraded within a few hours. Not so the vaccine RNA modified with pseudouridine. It is detectable in the body for at least 2 months.

Integration, an incorporation of the vaccine mRNA into the genome, was demonstrated in vitro in 2021. Thus, a continuous production of the spike protein would be possible.

#### The German Corona Tragedy

"You are now out of social life." (Tobias Hans, former prime minister of Saarland). "I am grateful that citizens are vigilant and help us." #### **Reconditioning and legal processing NOW**

Curfews, school and kindergarten closures, quarantine, contact bans, standoff rule, assembly ban, mandatory masking, a facility-based mandatory vaccination......The encroachment on fundamental rights was huge. Other countries like Sweden did it better.

German politics could have decided differently since 2021 at the latest:

• March 2020: the world-renowned US epidemiologist John loannidis classifies the COVID-19 disease as a moderately severe flu with a comparable mortality rate - he should be right!

- April 2020: Face masks bring no benefit.
- February 2021: The low efficacy of the vaccines is published for the first time.
- May 2021: The reduction of innate immunity by Corona vaccination is described.
- June 2021: Severe side effects and deaths from vaccination are described.

The German Corona policy was a disaster and failed on all levels, as did the expert council of the federal government, as well as the responsible federal institutes, the RKI and the PEI, and also the GERMAN ETHICS COUNCIL. A controversial public scientific discussion was prevented, critics were defamed.
